FACTS AND CIRCUMSTANCES:

THE PUBLIC SUPPORT PERCENTAGE HAS BEEN IN EXCESS OF 10%. THE FOUNDATION IS ORGANIZED AND OPERATES IN A MANNER TO ATTRACT ADDITIONAL PUBLIC SUPPORT. A SIGNIFICANT AMOUNT OF SUPPORT TO THE FOUNDATION COMES FROM INVESTMENT INCOME FROM ITS ENDOWMENT FUNDS WHICH WERE ORIGINALLY CONTRIBUTED FROM THE GENERAL PUBLIC. SUPPORT FROM CONTRIBUTIONS HAVE BEEN FROM A REPRESENTATIVE NUMBER OF PERSONS PRIMARILY IN TIPTON COUNTY AND ARE NOT FROM A SINGLE FAMILY.
